**Conditions For Breeding:**

1. Prior to the stud service, the bitch owner shall provide all of the following information to the stud owner via email or mail:

**Required**

- Copy of AKC Pedigree
- Copy of Normal OFA Hip Report
- Copy of Board –Certified Ophthalmologist's CERF Report

**Recommended**

- Copy of Normal Elbow Report
- Copy of CNM Report
- Copy of EIC Report
- Copy of Up-To-Date Shot Records With Dates:

2. The stud owner will not be liable for injuries that may be sustained by the bitch during the breeding process.

3. The bitch owner agrees to perform progesterone testing on the bitch to determine when the proper breeding will take place. Furthermore, the bitch owner will be responsible for any and all medical expenses, including all veterinary and travel fees.

4. Any or all of the following breeding methods may be used, by agreement of the parties and with payment of all costs or charges. For all breedings, a nonrefundable deposit is due before the stud service is performed. Four live puppies will constitute a litter. If less than four puppies are whelped, the remaining fees will be prorated based on the number in the litter. Full payment is required within two weeks after the whelping of a litter. The stud owner will sign the litter registration after receipt of full payment.

**A. Side by Side AI.** The stud fee is \$500. This fee is for a one-time breeding. Of this fee, a \$100 deposit will be paid at the time of the breeding. Any/all travel expenses incurred by the stud owner will be covered by the bitch owner. The bitch owner agrees to have a back-up stud dog available in the event the stud dog is servicing another bitch or is otherwise unavailable during the breeding window. If the bitch does not conceive on the first attempt, one additional service will be provided within the next 12 months at the bitch owner’s option. The \$100 deposit will then be applied for this second attempt.

**B. Fresh Chilled.** The stud fee is \$500. Of this fee, a deposit of \$100 must be received by the stud owner prior to the shipment of fresh chilled semen. The bitch owner will be responsible for all shipping and veterinary expenses. The bitch owner agrees to provide a credit card number to the collecting veterinarian to cover any costs.

**C. Frozen.** The stud fee is \$500. Of this fee, a deposit of 50%, or \$250, must be received by the stud owner prior to the release of semen from the bank. Any costs for shipping and handling will be paid directly to the semen bank by the bitch owner. Any AI veterinary expenses are the responsibility of the bitch owner.

- 5. The bitch owner agrees that no puppy from this breeding will be sold to a pet shop, agent, or broker.
- 6. The stud owner is not obligated to sign an application for litter registration with the AKC or UKC, nor may such application be made, unless/until all applicable terms of this agreement have been complied with in full.
- 7. If the bitch owner fails to fulfill the conditions of this agreement, the bitch owner will be responsible for all reasonable attorney’s fees, costs, and expenses incurred by the stud owner to ensure compliance with this agreement.
- 8. Payment will be made by cash or check made out to stud owner, Riley Sandall. An invoice will be sent via email after the deposit is received and the stud service completed. The invoice will contain the remainder of the stud fee and any applicable shipping or veterinary expenses as detailed above and agreed on by the bitch owner. Full payment is due within two weeks of the whelping of a litter.
